21-053 **CVEA MASTER AGREEMENT**

WHEREAS, the Board and the Conotton Valley Education Association (“the Association”) are parties to a Master Agreement, which governs the wages, hours, and other terms and conditions of the employment of Association members; and

WHEREAS, the current Master Agreement between the parties expires June 30, 2021; and

WHEREAS, the parties have negotiated a successor Master Agreement to be effective July 1, 2021 through June 30, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Conotton Valley Union Local School District, Sherrodsville, Ohio, that:

Section 1. The Board hereby approves the Master Agreement with the Association dated July 1, 2021 through June 30, 2024, a copy thereof is attached hereto.

Section 2. The Board hereby authorizes the Board President, Superintendent, and Treasurer to execute the Master Agreement on behalf of the Board, and to do all other things necessary and appropriate pursuant to the terms of the Master Agreement.

Section 3. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including O.R.C. §121.22 and Section 12 of H.B. 197, and any amendments thereto.
